EDITOR'S COMMENT

To coincide with the fourth National Workplace Wellbeing Day (which took place on 13 April), research undertaken by Ibec revealed that nearly half of the 1,000 employees surveyed would leave a job where an employer does not care about their wellbeing.

There was a significant increase on the 500-plus companies who participated in last year's National Workplace Wellbeing Day, to raise awareness of the importance and benefits of healthier lifestyles, and to improve employee wellbeing by promoting better exercise and nutrition in the workplace.

According to the World Health Organisation, there are many benefits of workplace health promotion for employers and employees, including reduced absenteeism, increased productivity, reduced stress, improved sense of well-being and improved morale.

In this edition of 'Health & Safety Times' we take a special look at the issue, and find that there's a changing mindset on the need to incorporate more health and wellness initiatives and programmes in Irish workplaces.

We contacted a number of leading consultancy companies who offer HR advice, corporate health and wellness programmes, and health innovation training services. And the general consensus was that there's been a considerable growth in awareness of employee wellbeing, while a number of factors have contributed to this increased

awareness.

According to one consultant, many employers in Ireland now understand and have accepted the many benefits to their business in

looking after the health and wellbeing of their employees.

Another one noted that while 52% of US employees have access to a health and wellness programme, this figure is only 23% in Europe, and claims that while Ireland would be seen as a leader in Europe, we've a long way to go to catch up to the US.

In fact, workplace wellness is viewed as a business imperative by a leading HR consultancy, and it recently conducted research which found that employees' personal health was the second most significant issue to cause employees stress about their financial security.
